CAR-RT SORT **CR 17

This month's featured cover is another interesting example of modern postal history. The #10 envelope features a junk mail political cover to a recipient in Kansas City, MO. This cover is franked with the 4 ϕ Stagecoach from the transportation series, Scott # 1898Ab. The stamp is Bureau precanceled Nonprofit Org and shows plate # 4 and was printed on Cottrell press. 4 ϕ Stagecoach covers with plate numbers are very rare with few surviving covers. The stamp was released Aug 19, 1982, so the cover was used after that date. It is an example of a discount rate for nonprofit organizations and was referred to as false franking by the postal service. The mailer applied the stamp to each piece and assembled a pack of say 1000 covers and paid the difference in cash for the actual nonprofit rate at the time of mailing. Note that the envelope just above the address is

endorsed, "CAR-RT SORT **CR 17." The receipt of mailing would show the additional postage paid for the entire mailing if the rate at the time of mailing was greater than the postage applied or a refund if less than the postage applied at the time of mailing. For example, the nonprofit rate for carrier-route sort from 01/09/83 to 02/16/85 was $3.3 \, \phi$ per piece. Applying the $4 \, \phi$ stamp represented an overpayment of postage of $0.7 \, \phi$ per piece. So the mailer would have received a refund of \$7.00 per 1000 pieces mailed. The cover is a nice representative example of false franking on a very scarce plate # coil cover. Of course, there is no way to reconstruct the actual date of mailing except if the cover retained its original contents which it does not. Most of the time, the contents indicate an approximate period of mailing.
